Due to the continuing concerns about the coronavirus (COVID-19) pandemic, the board of directors voted to transition the 2021 Montreal Lions Clubs International Convention to a virtual event that will be delivered totally online. This decision was made with the health and safety of our Lions, staff and vendors in mind as limiting international travel and large gatherings is key to global containment strategies.

Although we are disappointed that we won't be able to host this event in person, we are excited about hosting our first virtual international convention that can safely connect Lions from around the world. We are still finalizing the details of your new convention experience, and will share those with you as soon as they are ready.

Here are some important details about the 2021 virtual convention we'd like to share with you:

- Everyone's invited Our 2021 convention will be a virtual event that's open to all Lions and Leos around the world.
- Registration fees The registration fee will be US\$50 until March 31, then US\$75 beginning April 1. The registration fee for Leos will be US\$30 regardless of date. Convention is currently scheduled for June 25-29. Additional event and registration details will be provided soon.
- Current registrants Lions who are currently registered for convention will receive an email soon with more information about their registration options.
- Elections Executive officer and international director elections will be conducted electronically, and voting procedures will be forthcoming.

RIO VISTA LIONS CLUB ESTABLISHES a 501C3 FOUNDATION.

The club decided to form a 501C3 Foundation to handle all of their charitable projects. It was felt, that being a tax deductible charity, would increase participation by the public. PDG Warren Oglove was tasked with handling the paperwork involved. Below is an explanation of what has to be done.

First of all, Lions Clubs international must give their blessing. They have a couple of very important directions. The foundation must have the Lions club & locale in the name. They require other paperwork, which is simple, as they provide samples. They provided sample By-Laws for the foundation & a sample of the Minutes of a club formal meeting, at which, the club members approve the Foundation. One of their requirements is the club be a Corporation. Once incorporated, you need a tax ID number, as the Corporation is a separate entity from the club. Then comes the fun. The IRS has a form 1023, which is the form used to gain approval from the IRS. They have a form 1023EZ, if the charity has under \$50,000 income annually. As our club surpasses that amount, we had to file the long form. It's only 28 pages. Once Lion Warren reviewed it all, he decided he needed a person familiar with 501C3 organisations. He lucked out, as his cousin was good friends with an attorney that works for a 501C3 organisation. He talked to the attorney & found that they would help, however, not in an official capacity. They would give advice only, at no charge. There are companies willing to handle the paperwork for groups wishing to gain tax exemption status. Their costs run over \$1000. A lot of the questions on the form 1023 deal with the political side of things. Many of the large PAC's are registered charities, allowing a person to donate to a particular political party & receive a tax deduction. Another issue with the IRS has to deal with are scholarships/grants to individuals. The IRS wants 5 years of financial information from the applicant. I was working from the 5 years of our club's tax returns. A real job! It was time to talk to our 'advisor'! She asked how long we've been organised & I told her over 80 years. 'WRONG' she said. We've been organised for 1 month. That's how long our Foundation has been in existence. She gave me a friendly lecture on how to answer questions etc. Mainly there are no answers as we've been in existence for the month. After she was done with me, I felt as if I were a criminal & I was going before a Hearing Officer. The paperwork was finished & has been submitted to the IRS. Once filed, the IRS allows the foundation to act as a 501C3, as they say approval may take 6 months or longer. Rio Vista Lions club Foundation is now up & running. One last comment. All that has to be changed at the club level, is the charitable bank account. It has to reflect the name of the Foundation AND ... the Foundation files separate tax returns. It's a separate business
